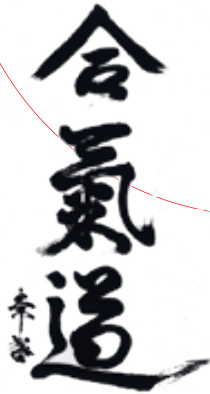


VALENTINE SEMINAR DEDICATED TO CANCER FIGHTERS

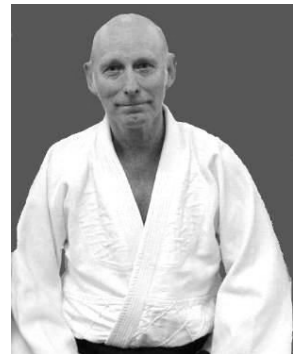
