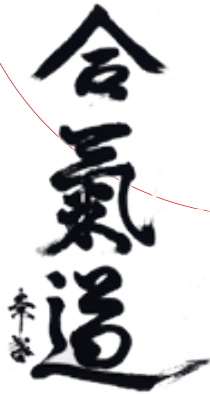


**VALENTINE SEMINAR

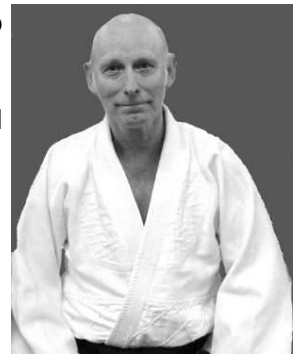
